Water

Our collaboration with Friends of Lakes to provide end-to-end solutions in the area of water conservation, saw us achieve many milestones with generous funding from our supporters.







Lake Rejuvination Projects

Rajanakunte, Yelehanka, North Bengaluru, Karnataka

Sadenahalli Lake

339 labourers and 16 tractors worked for over 87 days, clearing 1100 sq meters of weeds and shrubs, desilting over 400 sq meters of the lakebed, excavating over 32,000 tons of silt and sand and clearing encroachments

Ittgalpura Lake

291 labourers, 3 tippers and 3 tractors worked over 77 days, clearing 20,000 tons of silt and sand, removing weeds and widening pathways

Kannur Lake

Built various civic amenities such as toilets, a quarters for the security gaurds and a gazebo



The Impact

A comprehensive and scientific approach was adopted when undertaking these projects that resulted in:

- Engaging a considerable number of laborers and modern machinery, creating a broader socio-economic impact of providing employment to farmers in the vicinity
- Creation of wetland achieved by planting 3000+ trees across these lakes, further emphasizing the sustainable vision of the projects
- Over 75 farmers around the lakes acquiring over 2300 tons of fertile top soil for their farms



Water

Traditional Open Step Well Construction

Lalbaug Botanical Gardens, Bengaluru, Karnataka

In a first in over five decades, for the city of Bengaluru, a 26 feet wide and 23 feet deep traditional step well was built with the intention of recharging groundwater, avoiding waterlogging, and safeguarding the rare trees within the historical gardens from decay.

It also resulted in providing a steady water source in summer, when the water table depletes, and providing livelihood to a dozen well diggers over a period of 4 months.

Infrastructure Enhancement

Government Schools, Madurai, Tamil Nadu

Three Government schools— Maasathiyar Corporation GHSS, Kaakaipaadiniyar Corporation GHSS, and Velliveethiyar Corporation GHSS, were alloted computer centres, eqipped with latest Dell computers, printers, air conditioners, and furniture.

The gold medal winning champions of Avvai Corporation GHSS, were presented with state-of-the-art sporting equipment—fencing sets, pro boxing training kits including punching bags, carrom boards and table tennis equipment.

Healthcare

Medical Equipment

Chitturi Sub-Centre and Bithari Charitable Dispensary, Bithari, West Bengal Essential medical equipment such as an ECG machine, blood pressure monitor, D&C medical instruments kit, surgical needle holder, electric sterilizer, a set of metal surgical examination lamps, height measuring scales, digital adult weighing machine as well as baby tray weighing machine, fetal doppler, chairs and tables with wheels and a pedestal fan; were donated to the Chitturi Sub-Centre and Bithari Charitable dispensary at Bithari.

These will be especially used for women and children from low-income groups, as well as tuberculosis patients and regular patients from 396 villages of 44 Gram Panchayats within 10 Blocks, at North 24 parganas in West Bengal.

Medical Equipment and Laptops

Primary Healthcare Centres, Hyderabad, Telangana

In collaboration with the State Medical Department, laptops, as well as medical equipment such as a OT digital arm, lights and hydraulic tables; two-fold stretchers, double dome lights, ECG machines, examination, as well as delivery tables, BP apparatus, emergency drug tray trolleys, and cots with mattresses and pillows were given to over 10 Primary Healthcare Centres in Hyderabad and surrounding areas.

These will benefit over 10,000 individuals, mostly women and children over the next 5-7 years.
